Documents

- 2. (1) The pre-qualifier will receive a Miscellaneous Receipt in respect of payment for pre-qualification documents. These include the following forms in duplicate:

 - (iii) S 33: Confidential Business Questionnaire
 - (iv) The pre-qualifier should retain one set for his records and return the other set in accordance with these conditions.
- 2. (2) The pre-qualifier is required to check the number of pages of the documents accompanying the form of pre-qualification. Should he find any missing or any figure indistinct, or should he be in doubt about the precise meaning of any of the items of figure, for any reason whatsoever, he must inform the issuing office at once and have the matter rectified, before the final date for the submission of pre-qualifications.
- 2. (3) The pre-qualifier's signature to this document and to all documents, as required, which accompany the form of Pre-qualification, shall indicate that he fully understands their contents and that he accepts all the conditions stated or implied therein.

Submission of Pre-qualification

- 3. (2) The Form of Pre-qualification must be properly signed in ink, dated and witnessed and must accompany any other documents concerned with the pre-qualification.

Communication

7.
